1. GENERAL PROVISIONS.

1. The World Championship in Sports knife throwing among men and women (hereinafter referred to as the Championship) is held in accordance with the Rules of the «Sports knife throwing» sport approved by the International Amateur Federation «Unifight».
2. The Championship is held with the aim of development of the «Sports knife throwing» sport in the world.
3. The objectives of the Championship are:
 - a) Popularization of the «Sports knife throwing» sport and expansion of geography of the participating countries;
 - b) Determination of the world`s strongest athletes in «Sports knife throwing» ;
 - c) Strengthening of international sports ties and exchange of experience between National Federations.
4. It is prohibited to exert unlawful influence on the results of the Championship.
5. This Regulation is the basis for sending athletes, coaches, sports referees and other specialists in the field of physical culture and sports to the Championship.

2. MANAGEMENT OF PREPARATION AND CONDUCT OF THE CHAMPIONSHIP.

1. General issues of preparation and organization of events related to the Championship: preparation and installation of a site for competitions, provision of office equipment, involvement of mass media for coverage of competitions and other organizational issues are assigned to the organizing committee. The organizing committee includes: the International Amateur Federation «Universal Fight», the Sports and Cultural Center «Obrenovac» (Serbia).
2. The actual conduct of the Championship in Sports knife throwing among men and women is entrusted to the main Panel of judges.
3. The judging of the Championship is carried out in accordance with the Rules of the «Sports knife throwing» sport, approved by the International Amateur Federation «Unifight» (hereinafter referred to as the Rules).

The chief judge of the Championship is the judge of the international category V.S. Spirkin (Russia).

The Chief secretary of the Championship – by appointment.

3. THE PROGRAM OF THE CHAMPIONSHIP.

December 21:

Arrival of teams, accommodation.

14.00 – 16.00 – registration of participants;

16.00 – 17.30 – official training;

18.00 – Championship opening ceremony;

19.00 – 20.00 – draw of participants; press conference, joint meeting of the organizing committee, the Panel of judges and team representatives.

At the end of each day of the Championship, a meeting of the Panel of judges and team representatives is held in order to approve the results of the past day and plans for the next day.

December 22:

8.00 – 9.00 – warm-up,

9.00 – 20.00 – the first stage (preliminary, 5 series of 3 knives);

Sports disciplines:

- distance of 3 meters among women
- distance of 5 meters among men
- distance of 5 meters among women
- distance of 7 meters among men
- distance of 7 meters among women
- distance of 9 meters among men

December 23:

8.00 – 9.00 – warm-up, meeting of the Panel of judges.

9.00 – 13.00 – the second stage (final).

Sports disciplines:

- distance of 3 meters among women
- distance of 5 meters among men
- distance of 5 meters among women

- distance of 7 meters among men
- distance of 7 meters among women
- distance of 9 meters among men

14.00 – awarding of medal-holders and winners of the Championship. The closing ceremony of the Championship.

4. CONDITIONS OF THE CHAMPIONSHIP.

1. Athletes of 18 years and older are allowed to participate in the Championship. Athletes must be able to handle the sports equipment approved by the Rules, know and clearly follow the Rules for Sports knife throwing and the present Regulation and obtain a doctor`s permission to participate in this Championship.
2. Knives approved by the Rules of the «Sports knife throwing» sport are allowed for use at the Championship.
3. Participants` clothing: dark sports trousers, a T-shirt with logos of national Federations and the «Unifight» logo, it is possible to apply sponsors` logos in agreement with the organizing committee, sports shoes.
4. Judges` clothing: white shirt with short sleeves, black trousers, black sports shoes.
5. All athletes admitted to the Championship take part in it, and the Championship is held in two stages (preliminary, final), participate.

5. DETERMINATION AND AWARDING OF WINNERS.

1. Winners and medal- holders in each of the sports disciplines are determined by the highest number of points scored. In case of equality of points scored, the winner is the one who has the largest number of them in the last series.
2. All winners and medal-holders are awarded with diplomas and medals.
3. To determine the winners and medal-holders in the team competition among the participating countries, the estimated indicators of personal results of athletes are established: 1 place – 7 points, 2 place – 5 points, 3 place- 3 points, 4 place – 2 points, 5-8 -1 point.
4. Athletes who did not stand on the podium of the award, who left without the permission of the chairman of the organizing committee, lose their medals and diplomas.
5. All teams must have two national flags and the national anthem on CD for the opening, closing and awarding ceremonies.

6. TERMS OF FINANCING.

1. Travel, accommodation, meals for athletes are at the expense of national Ministries of Sports. Travel, accommodation, meals for coaches, representatives, accreditation of athletes are at the expense of personal funds.
2. Expenses related to the Championship – prizes, preparation of the completion site, medical care and other logistical support, in accordance with the estimates of the event are at the expense of sponsorship and charitable contributions.
3. Application fee for participation in the Championship: one distance – 35 euros, three distances – 100 euros.

7. LIVING CONDITIONS.

The cost of accommodation and meals in hotels during the Championship:

To ensure the safety of athletes and compliance with anti- smoking restrictions, accommodation in the above-mentioned hotels is MANDATORY. When booking, it is necessary to inform the hotel administrator about participation in the World Championship in Sports knife throwing.

8. QUESTIONS.

1. Foreign citizens are allowed to enter Serbia in the presence of a medical document confirming a negative result of a laboratory examination of the material for COVID-19 by PCR, not older than 48 hours from the date of receipt of the results.
2. For timely registration of documents, participants of the Championship must confirm their participation not later than November 15, 2021, indicating the passport data (photocopies of foreign passports) of all the members of the delegation by e-mail info@russmn.ru.
3. Athletes are allowed to enter the Championship on an application signed by the head of the National Federation or department, certified with a seal, and a doctor, which is submitted to the Admission Commission in one copy during the official registration of participants.
4. The following documents for each athlete should be attached to the application:
 - passport (original);
 - compulsory medical insurance policy (original);
 - the athlete`s classification record book with indication of the sports category;
 - negative result of laboratory examination of the material on COVID-19 by PCR.
5. The athlete against whom the disqualification was applied and who did not declare such disqualification to the Admission Commission, bears independent and full responsibility for this action.
6. Knives and transportation of knives to the place of the Championship and back should not contradict the current legislation, and the sending federation is responsible for their transportation.
7. Sports delegations arriving at the Championship must inform the organizing committee in advance of the date and time of arrival.
